DentPAC had in-kind transactions which are shown equally as revenue and an expense.

The month-end cash on hand decreased to \$185,682.95.

Income Statement:

Contributions consist of the following:

- Mandatory donations from members via the membership renewal process.
- Voluntary donations from members via the membership renewal process.
- Voluntary donations through an expense reimbursement form or by direct donation.

<u>In-Kind Contribution</u> - represents dollars spent on behalf of DentPAC by the Association for Board meeting costs, tax preparation services, etc.

<u>Donations & Contributions</u> - includes contributions to candidates for statewide and legislative office with current maximum contribution per candidate is \$2,400.00 per cycle for Legislative Candidates and \$4,800.00 per cycle for State Executive Candidates; Independent Expenditures which includes producing communications that promote or oppose a political candidate or initiative; and Committee Contributions that includes contributions to caucus leadership and other political action committees.

<u>In-Kind Expenses</u> - represents dollars spent on behalf of DentPAC by the Association for Board meeting costs, tax preparation services, PAC compliance and accounting services, etc.
